4. Eliminating discrimination

- Holding Collective Worships dealing with relevant issues. Pupils will be encouraged to take a lead in such Collective Worships. Pupils are invited to attend our pupil panels to advocate for change.
- Working with our local community. This includes inviting leaders of local faith groups to speak at Collective Worships, and organising school trips and activities based around the local community
